### **Antoine Savary, European Commission** *DG Home, Deputy Head of Unit dealing with legal migration & integration*



After having held several positions in the French local and national government, Antoine Savary joined the Joint research Center of the European Commission in 2004. Subsequently he moved to DG JLS (ex DGHOME) in 2007 where he became in 2012 Deputy Head of the Unit in charge of EU Funds in the field of migration. ### **Karsten Gerken, City of Leipzig** *Head of the Office for Urban Regeneration and Residential Development*



Since 1991 Head of the Office for Urban Regeneration and Residential Development, mainly responsible for the Development and Execution of the Urban Regeneration strategy for the city of Leipzig, the implementation of all subsidy programmes for urban regeneration and the coordination of municipal investments in urban renewal areas. Karsten is a project director for URBAN II and ERDF programmes and he is also responsible of small scale implementation of urban regeneration tasks as responsible organisation for urban renewal in Hamburg and development of administrative structures after the political change (1990) in Chemnitz.

Kristoffer is currently working as a community and development consultant in the Danish Federation of Social Housing, BL. ### **Michaela Kauer, Brussels Liaison Officer of the City of Vienna** *Director*



Michaela Kauer, born in 1966, was raised in Brussels and Vienna. After school, she worked with international youth organisations and became one of the first Austrian trainees with the European Commission in 1991. From 2001 onwards, she served as head of cabinet of two city councillors, Renate Brauner and Sonja Wehsely. In 2009, she was appointed director of the Brussels Liaison Office of the City of Vienna. In this function, she is the representative of Vienna in the Executive Committee of Eurocities and in the newly created EU Urban Partnership on Housing. She studied international public management and teaches European public policy in Austrian professional business schools.
