



AFFORDABLE HOUSING INITIATIVE SUMMIT “FINANCING THE ENERGY TRANSITION IN THE HOUSING SECTOR”

Before the onset of COVID-19, the social and affordable housing sector faced a €7bn annual investment gap, meaning that investment in this sector should have increased by 25% in Europe. Lack of investment in social and public housing and the recent climb in house prices has resulted in growing waiting lists. In addition, to bring the social and affordable housing stock to the Energy Performance Certificate Label B and A by 2050, the sector faces an extra investment gap of €13 billion for renovation every year. In a nutshell, housing providers are facing considerable constraints to delivering sufficient affordable homes and the renovation rates that would enable the energy transition.

A number of funding opportunities have been made available by the European Investment Bank and the European Union, which complemented by Structural Funds and national and local support schemes have potential to partially address the problem. These sources include InvestEU, Recovery and Resilience facility, European Local Energy Assistance (ELENA), the European Urban Initiative (EUI), Just Transition Mechanism, the Recovery Assistance for Cohesion and the Territories of Europe (REACT-EU), and the Life Programme. Arguably, the possibility to resort to these mechanisms is not immediately perceived by housing owners.

The [European Affordable Housing Consortium](#) and [Housing Europe](#) are bringing together in Paris housing and finance stakeholders to discuss hurdles faced by housing providers, municipalities and companies across the continent to access funding as they look to move the Renovation Wave and the New European Bauhaus forward. We will also jointly uncover novel and replicable financial solutions – from alternative funding to sustainable business models - that work for the people and communities.
